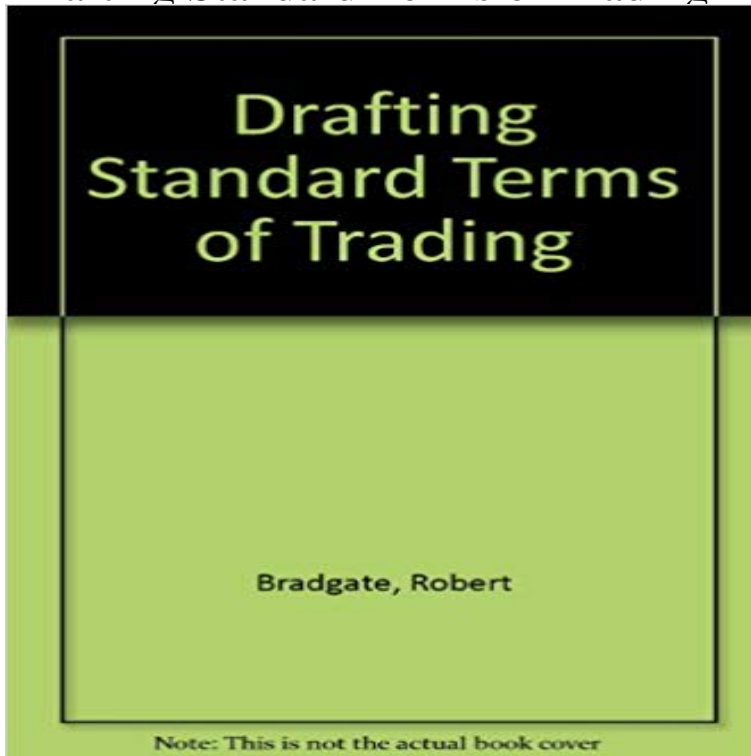


## Drafting Standard Terms of Trading
