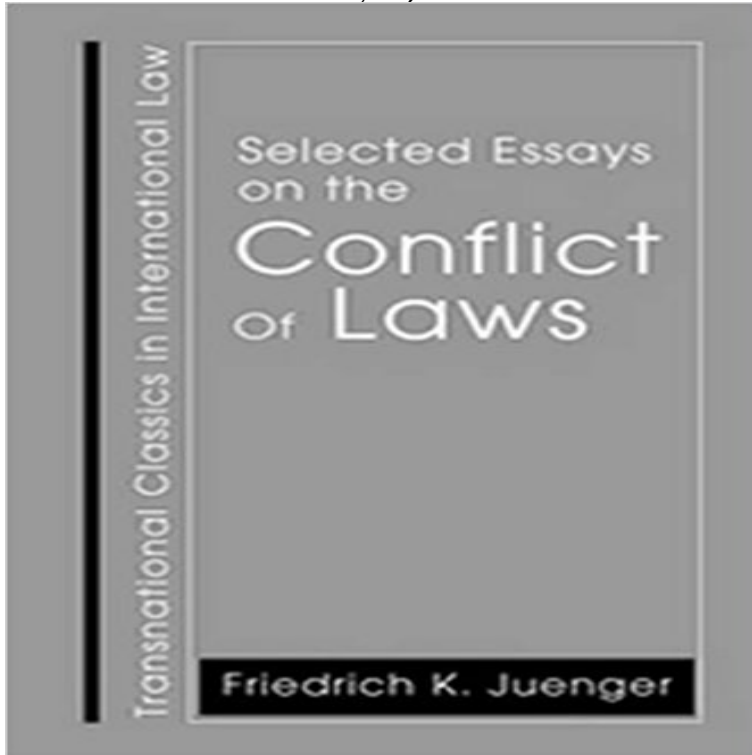


Selected Essays on the Conflict of Laws (Transnational Classics in International Law, 1)
