

## Sued for Debt - What If (I Think) I Really Owe the Debt Collectors Money?

Many debt collectors rely on unethical and unfair collections methods that violate the Fair Debt Collection Practices Act (FDCPA), which is the first and best source of debtor rights, among other laws. Debt collectors buy huge amounts of the riskiest debt for pennies on the dollar. Then they harass and dun the people who supposedly owe the money for a while, and then they file suit, often against dozens or hundreds of people at a time. This book looks at the moral questions associated with owing money supposedly to the debt collectors and comes up with a conclusion that may surprise you: you may have a moral duty to fight the debt collectors.
