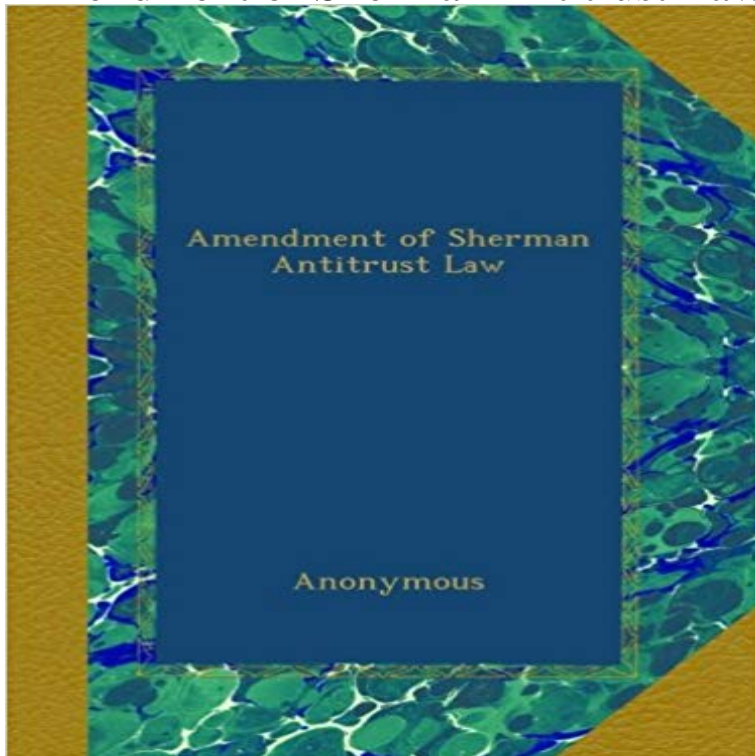


Amendment of Sherman Antitrust Law
