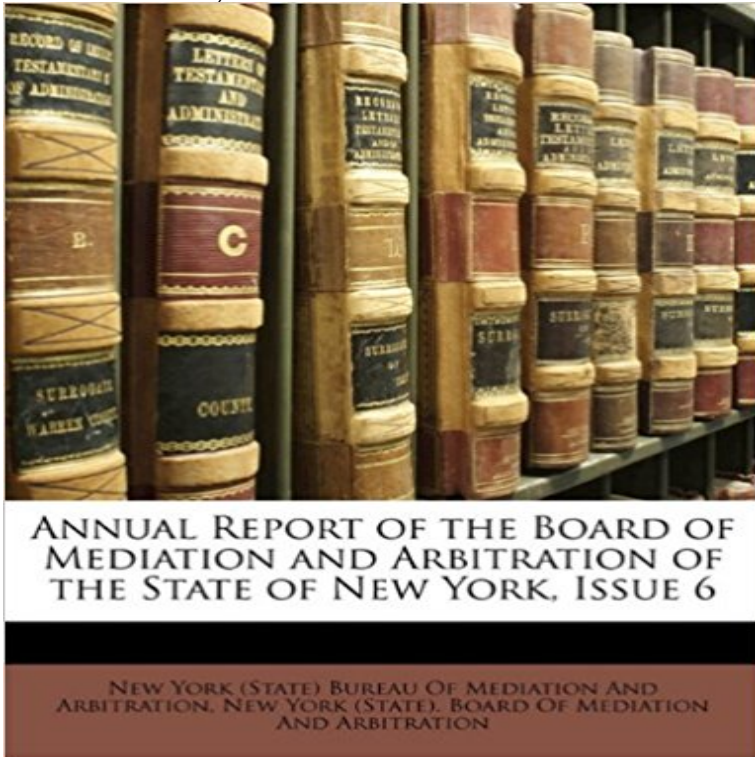


# Annual Report of the Board of Mediation and Arbitration of the State of New York, Issue 6
