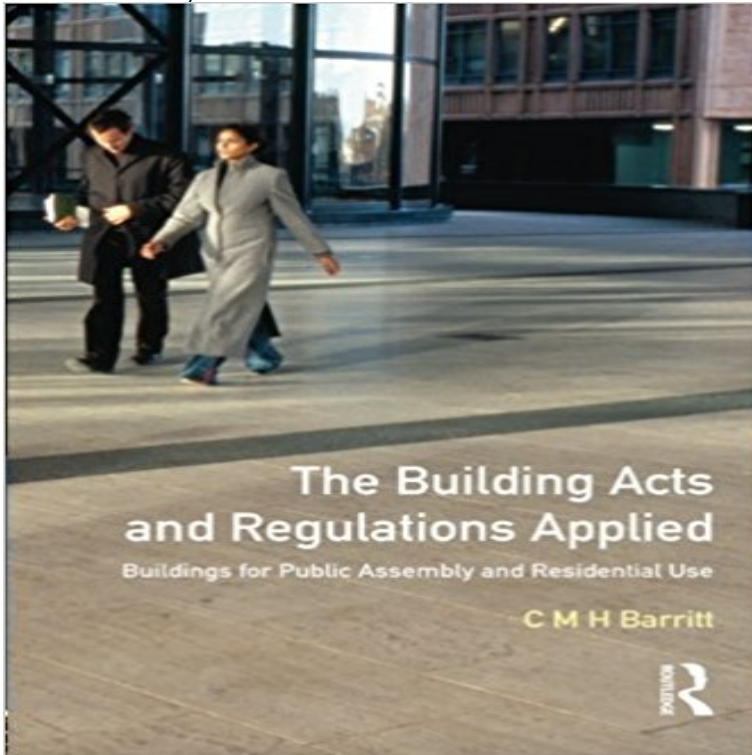


The Building Acts and Regulations Applied: Buildings for Public Assembly and Residential Use
