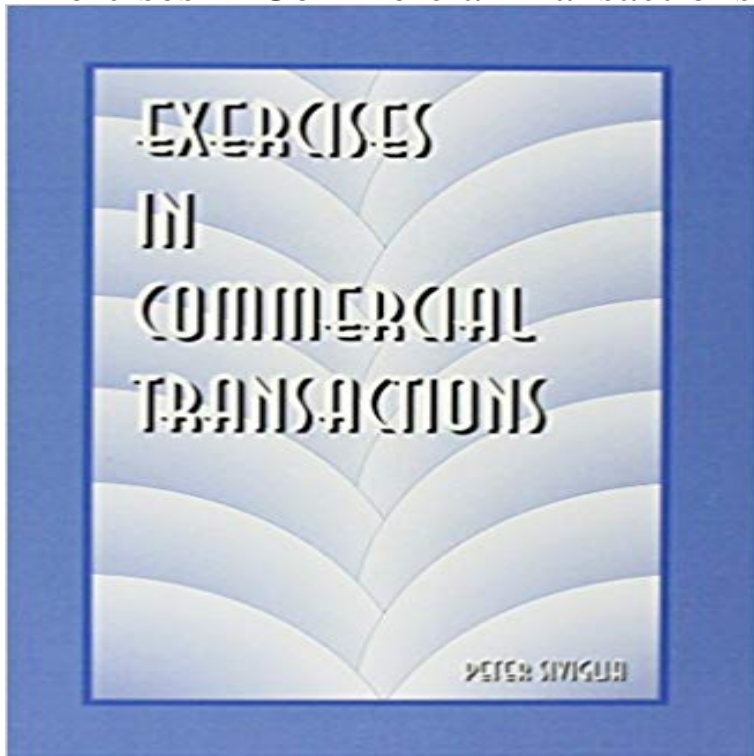


## Exercises in Commercial Transactions
