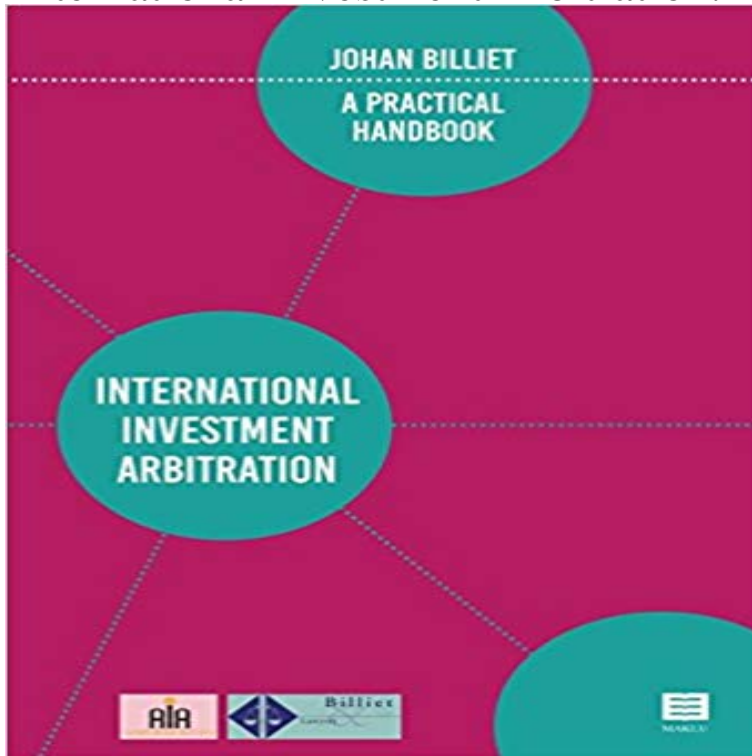


# International Investment Arbitration: A Practical Handbook
