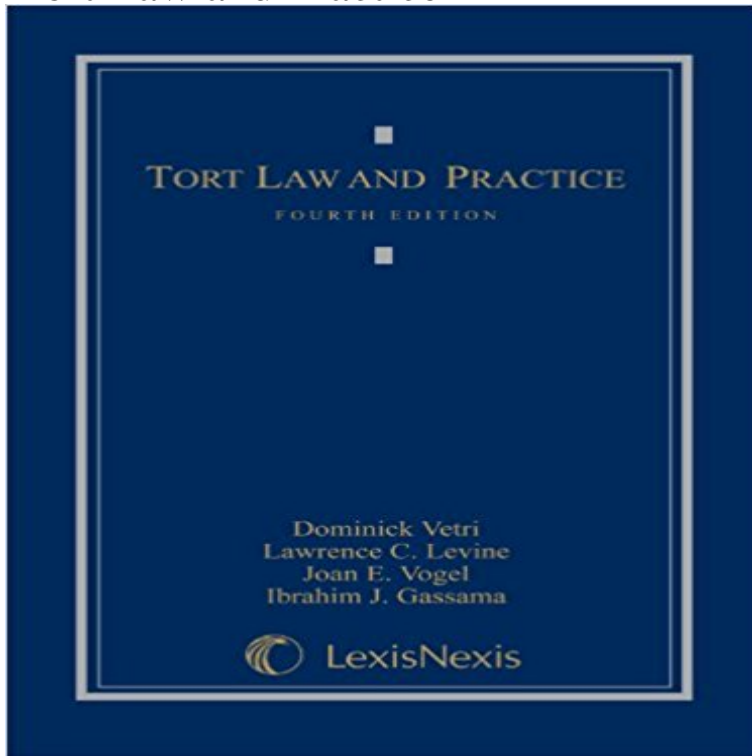


Tort Law and Practice
