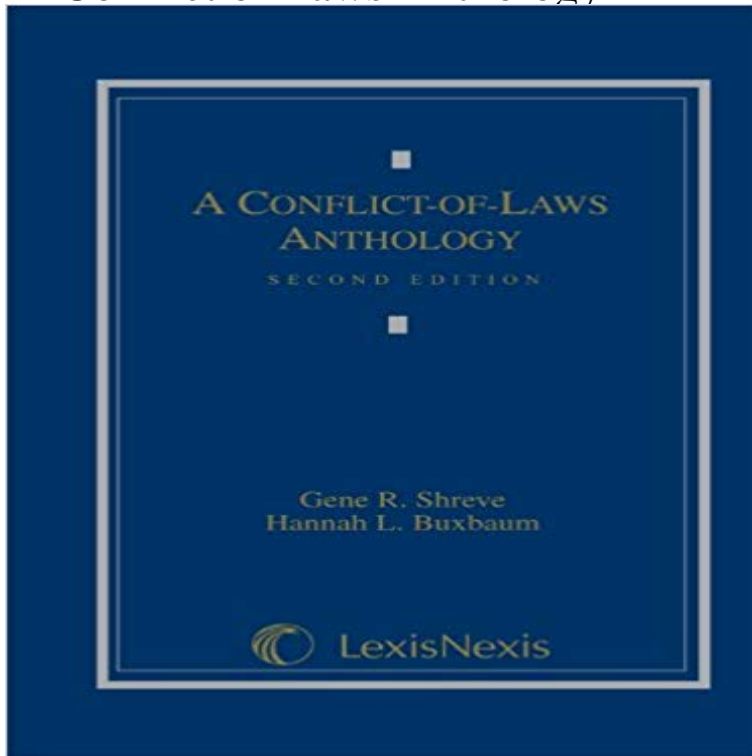


A Conflict of Laws Anthology
