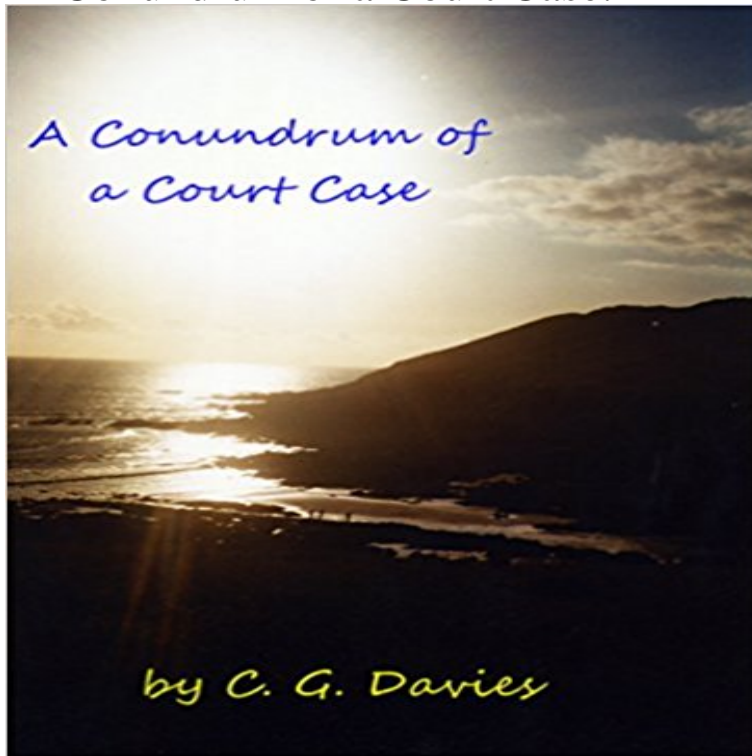


## A Conundrum of a Court Case.
