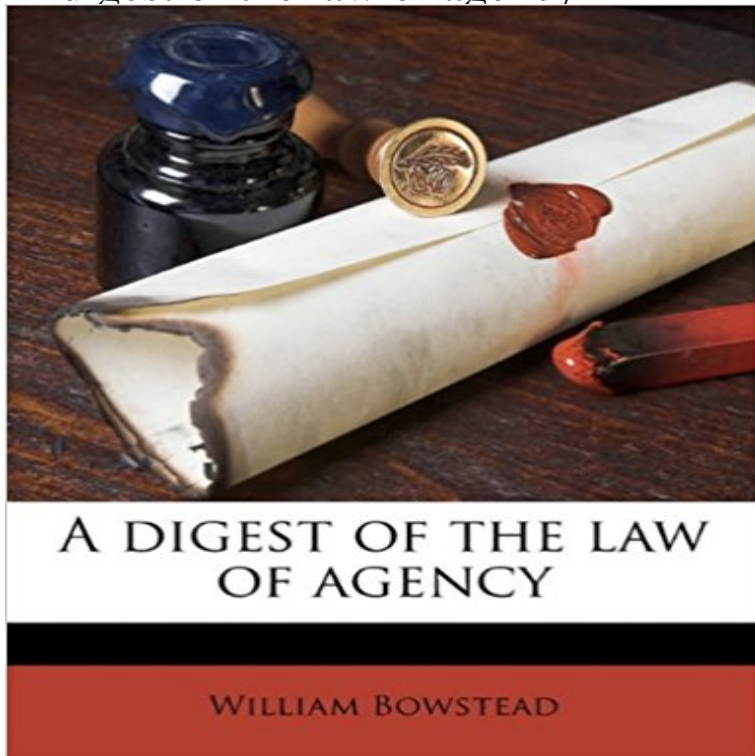


A digest of the law of agency
