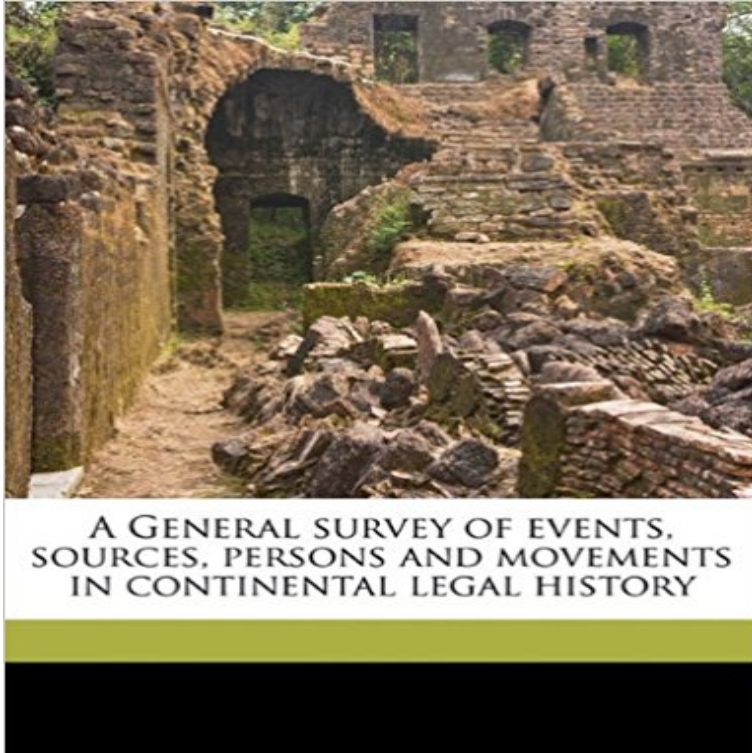


A General survey of events, sources, persons and movements in continental legal history
