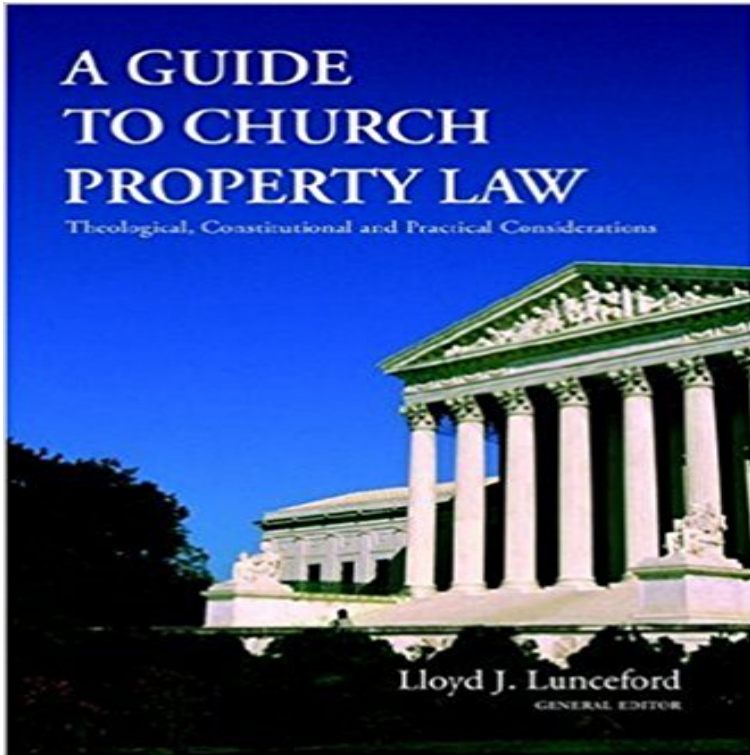


A Guide to Church Property Law: Theological, Constitutional and Practical Considerations
