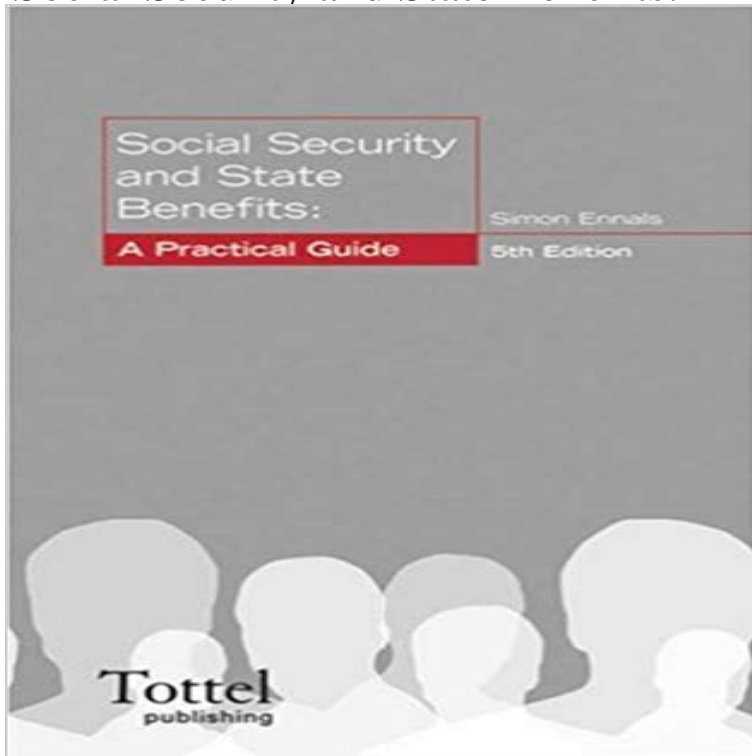


Social Security and State Benefits: A Practical Guide (Sixth Edition)
