

The world economic marketplace is getting smaller. Economic activity and commerce is now world-wide, and new markets are constantly opening and expanding. To compete successfully, businesses must grow and compete internationally. Expansion into international markets brings exposure to different legal systems, with different laws governing business transactions and different cultural norms. Contracts must be drafted differently to account for these different systems. In most cases, businesses adapt, and the outcome is usually within the normal risk allocation of routine business transactions. In some instances, however disagreements or disputes arise. Dispute resolution in the international marketplace is not the same as domestic dispute resolution in the United States. Most international businesses prefer to avoid dispute resolution in foreign courts. Arbitration is litigation; just litigation in another forum. International arbitration provides an alternate forum for resolution of these international commercial disputes. But international arbitration also has risks and disadvantages. This chapter will describe some of those risks and disadvantages, and provide the strategies to minimize them and achieve a prompt, efficient and fair resolution to business disputes that cannot be resolved amicably.
