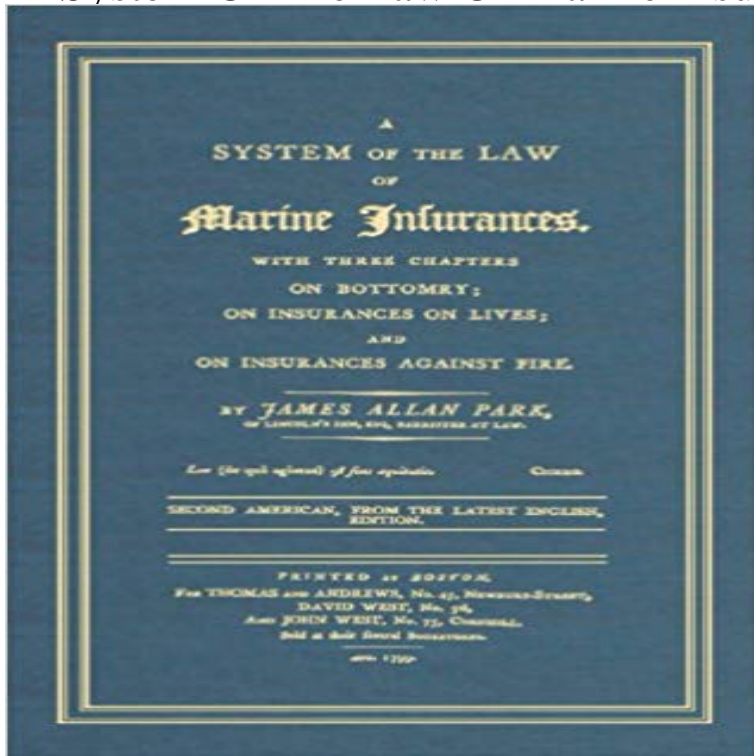

The following chapters explain average, salvage, abandonment and how insurance policies are constructed. The final sections address liability and topics dealing with procedure and evidence.
