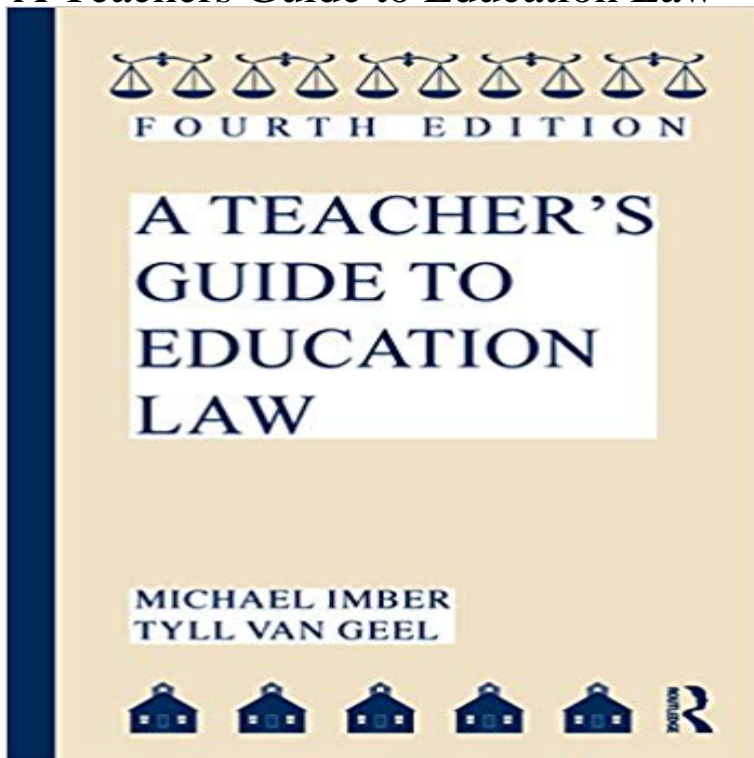


A Teachers Guide to Education Law
