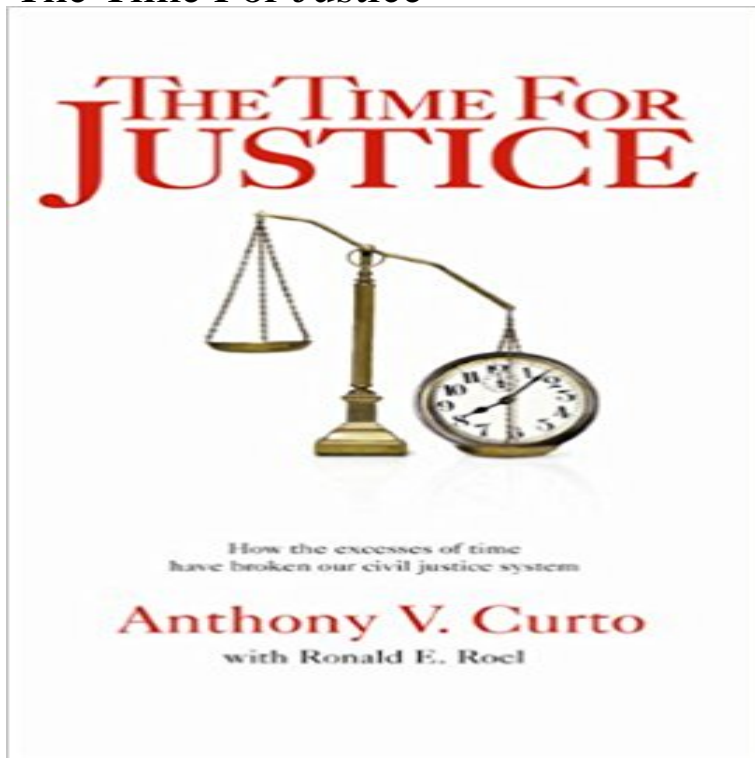


## The Time For Justice
