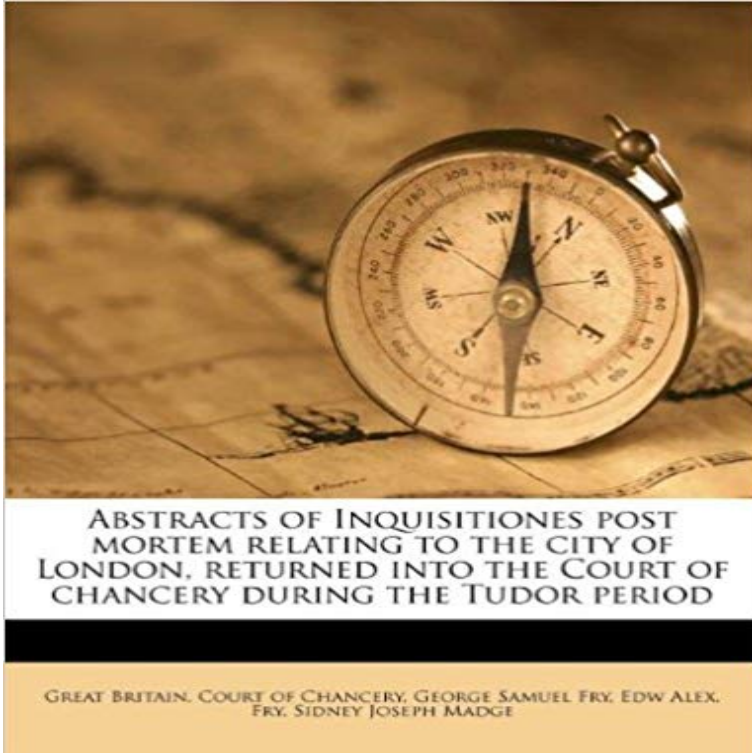


# Abstracts of Inquisitiones post mortem relating to the city of London, returned into the Court of chancery during the Tudor period
