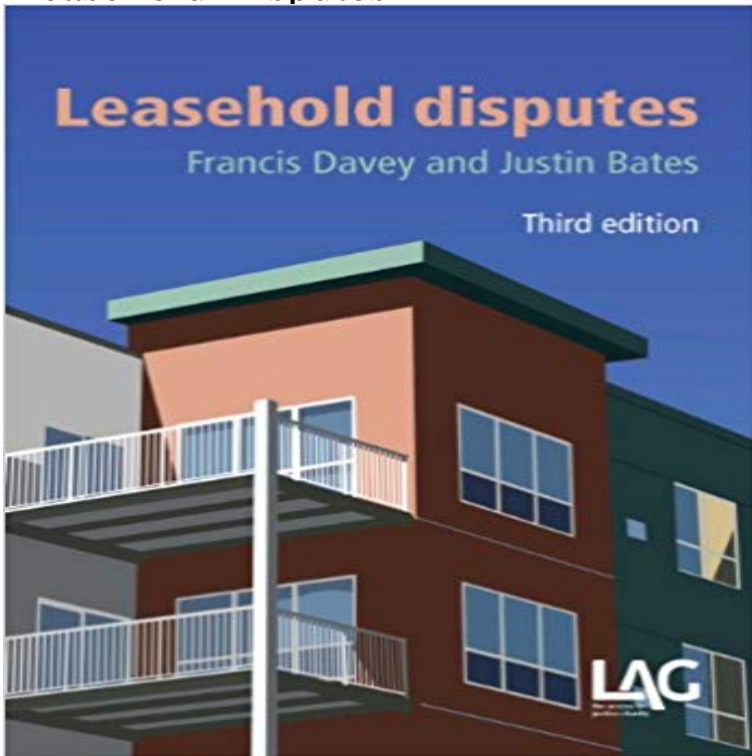


# Leasehold Disputes
