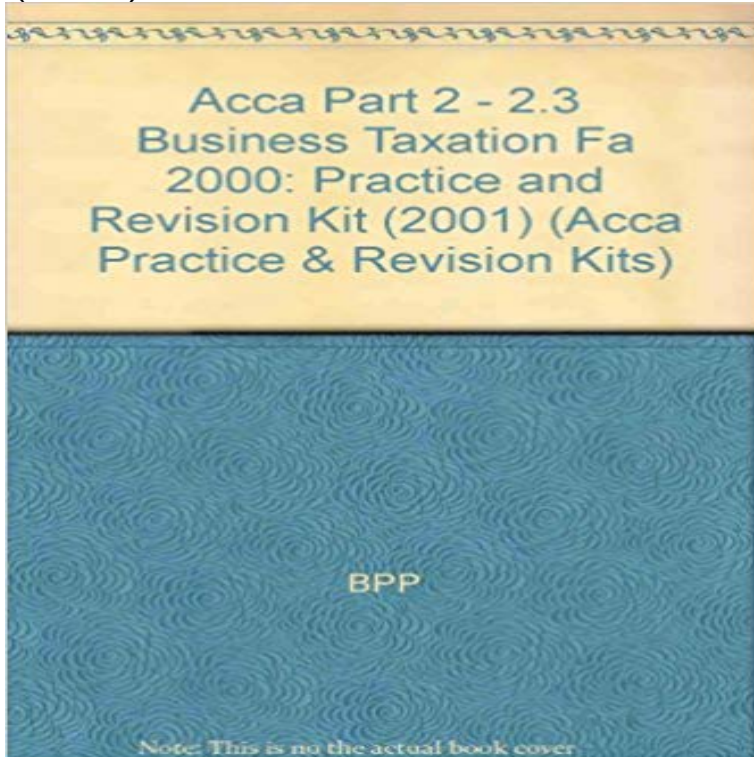


## Acca Part 2 - 2.3 Business Taxation Fa 2000: Practice and Revision Kit (2001)
