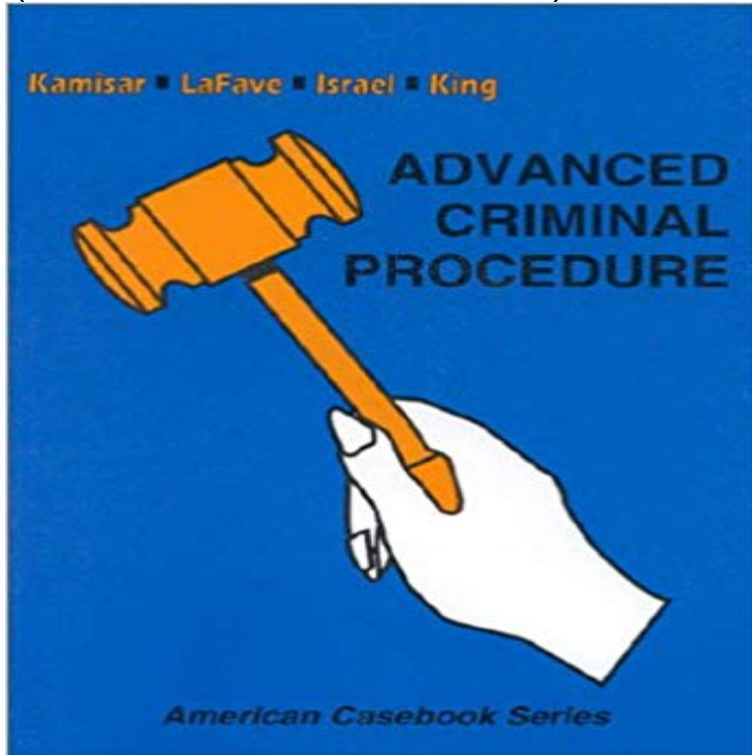


Advanced Criminal Procedure: Cases, Comments and Questions (American Casebook Series)
