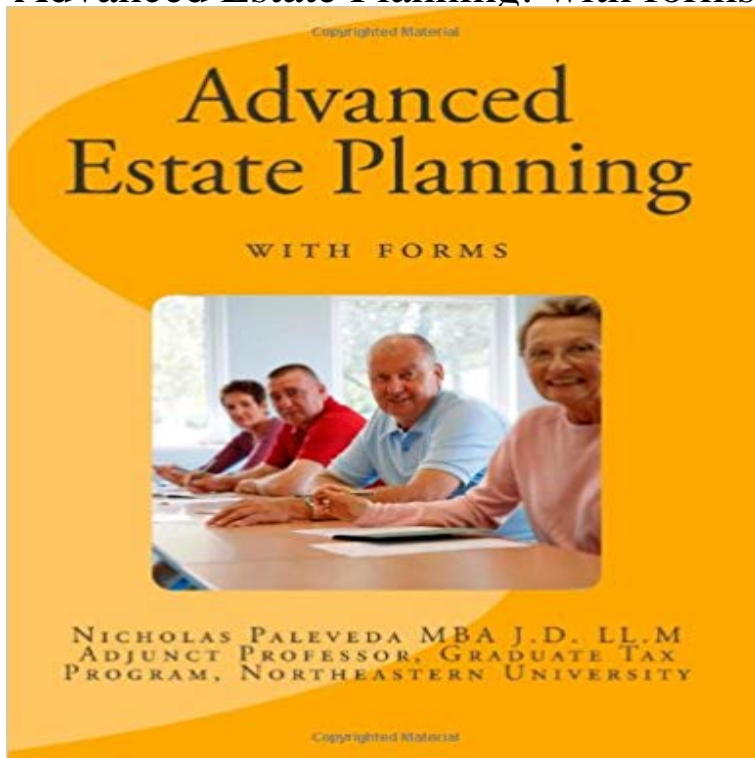


## Advanced Estate Planning: with forms
