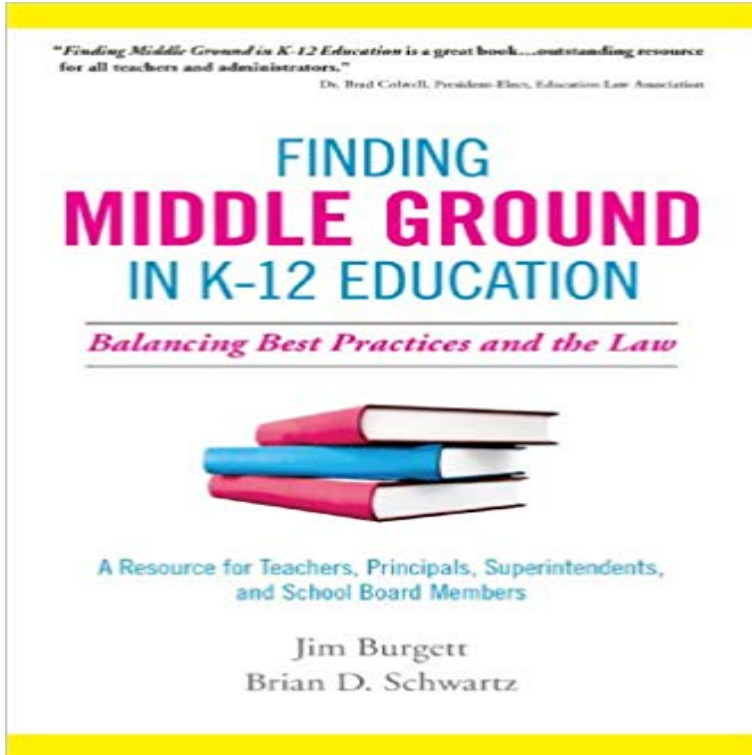


Finding Middle Ground in K-12 Education: Balancing Best Practices and the Law
