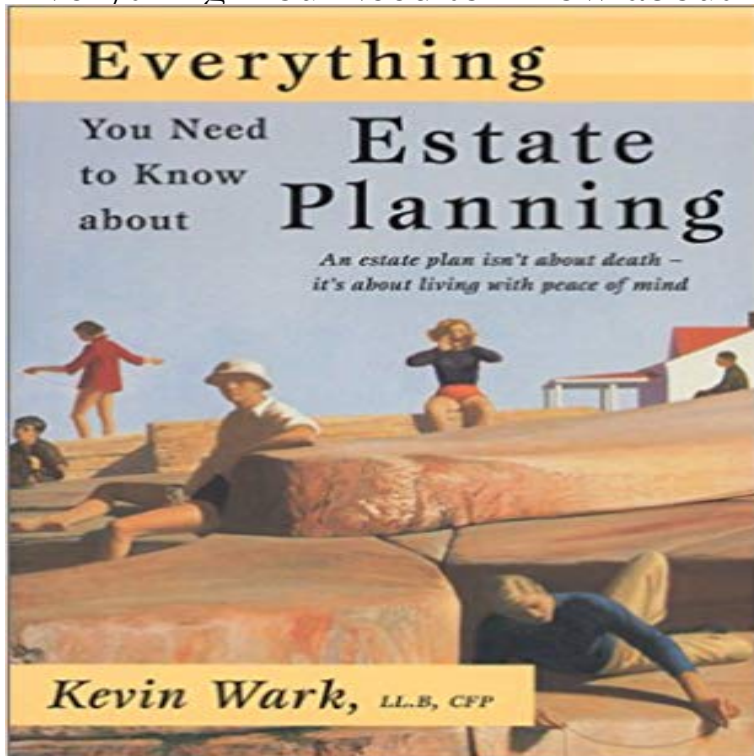


Everything You Need to Know about Estate Planning
