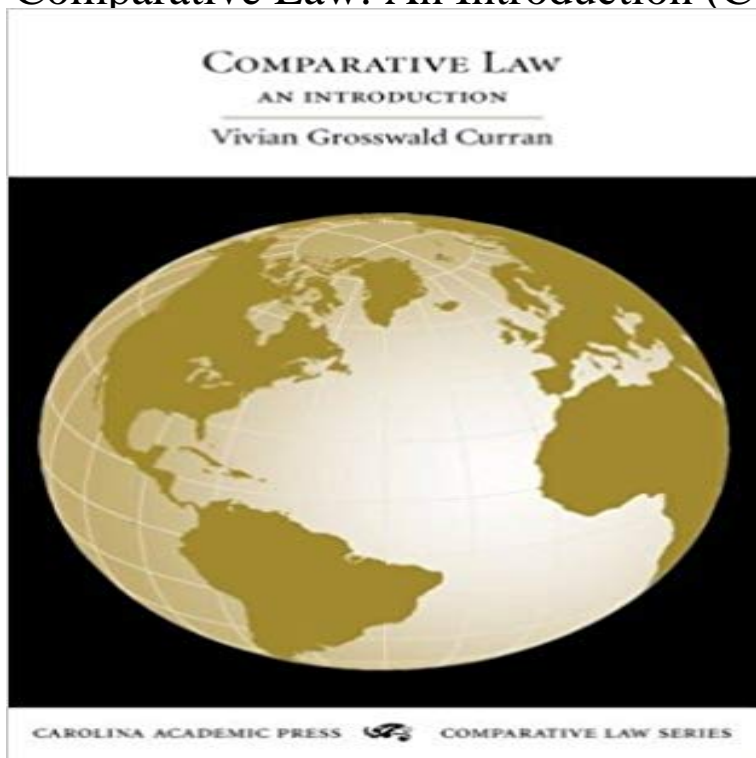


Comparative Law: An Introduction (Comparative Law Series)
