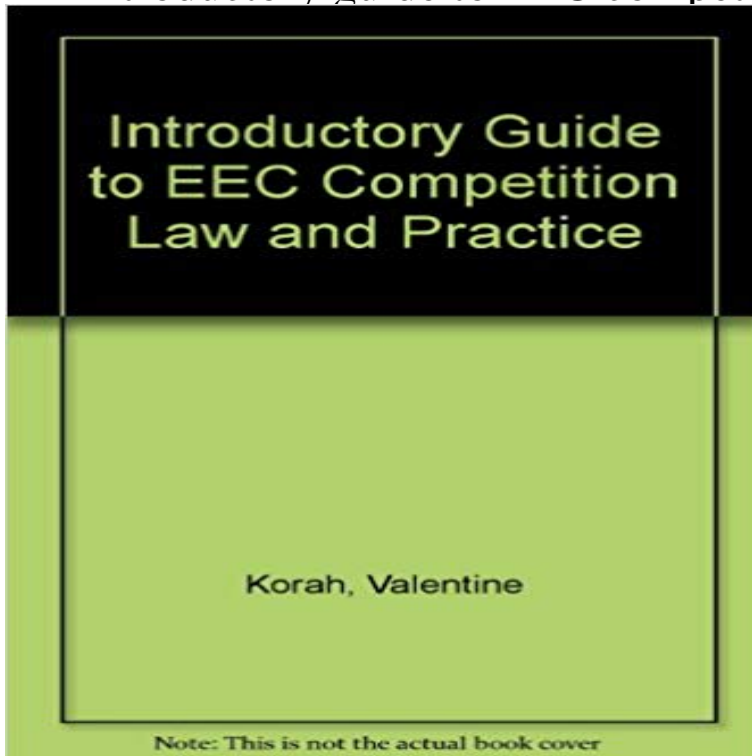


An introductory guide to EEC competition law and practice
