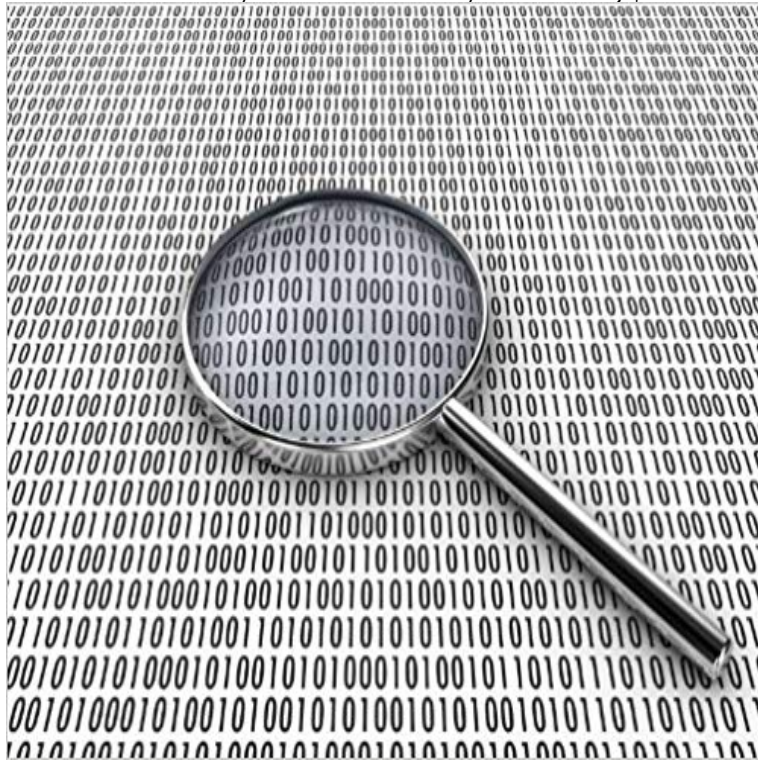


E-Discovery Nuts and Bolts for Paralegals: The Essentials of E-Discovery That Every Paralegal Needs to Know
