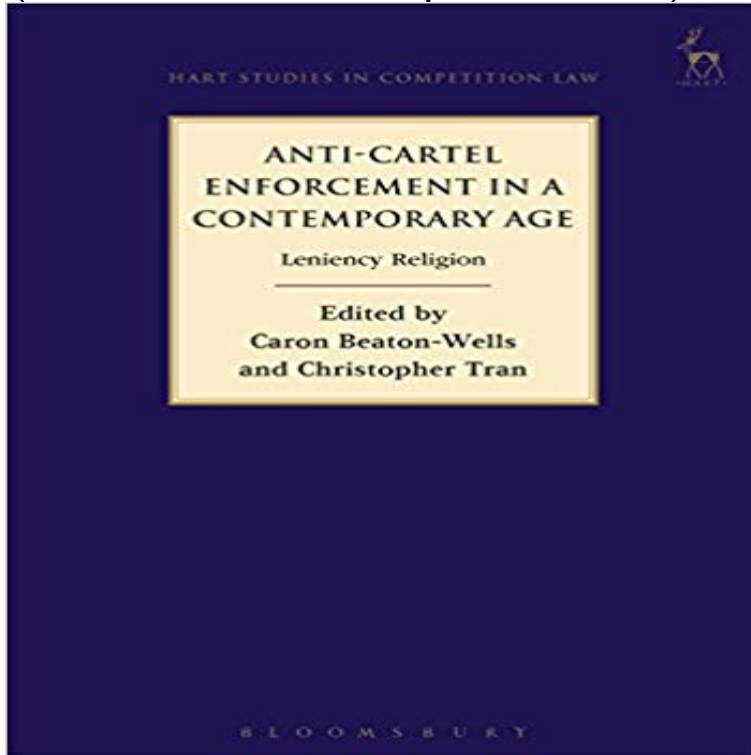


## Anti-Cartel Enforcement in a Contemporary Age: Leniency Religion (Hart Studies in Competition Law)
