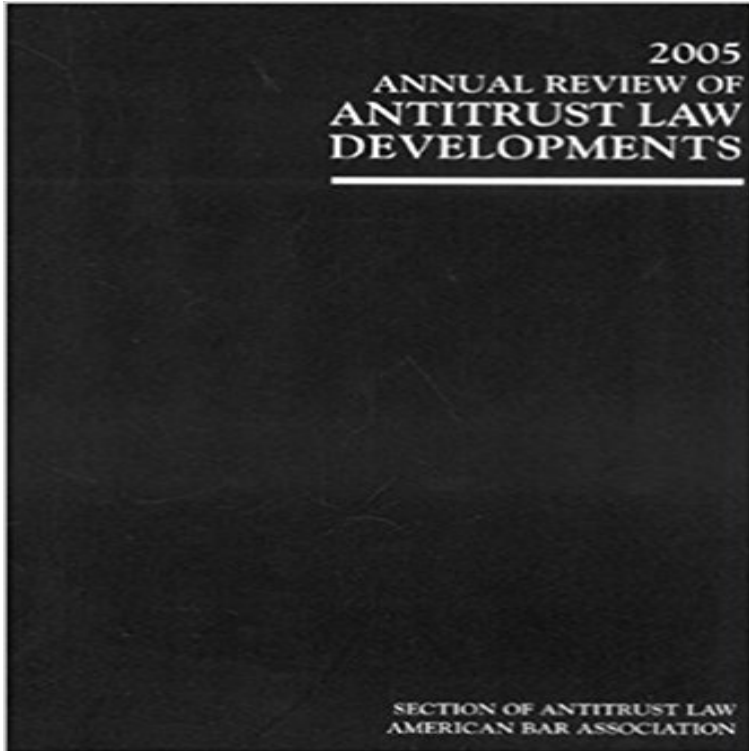


2005 Annual Review of Antitrust Law Developments
