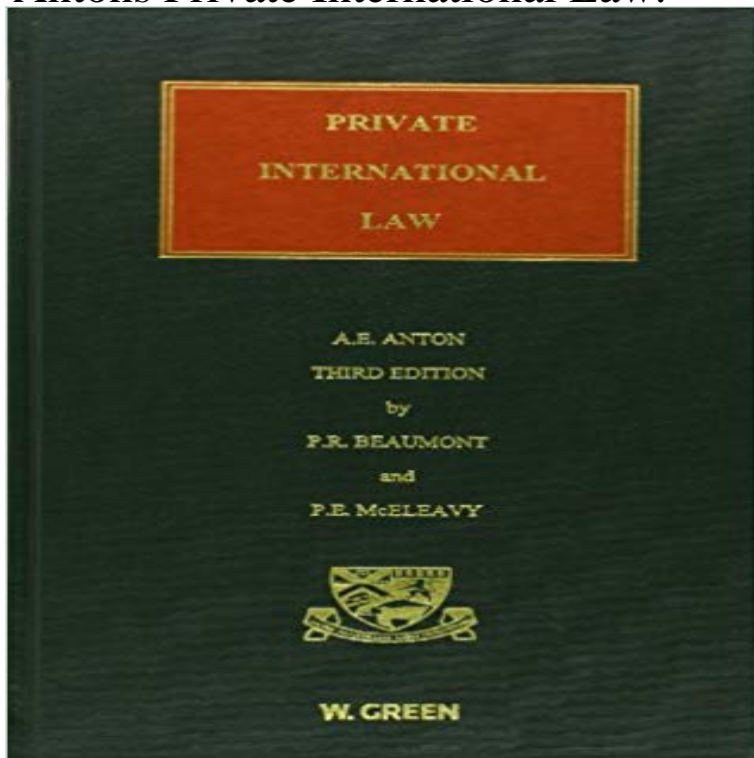


## Antons Private International Law.
