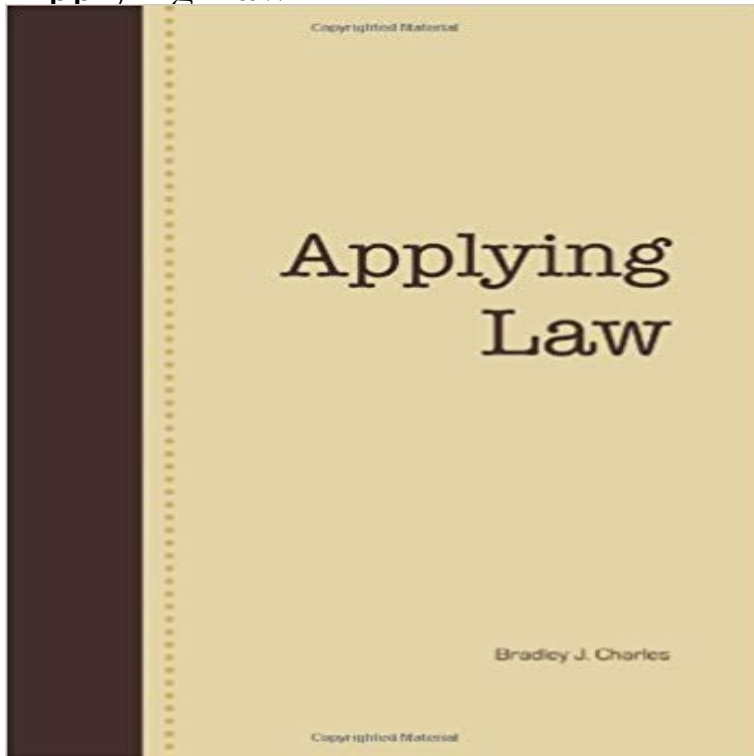


## Applying Law
