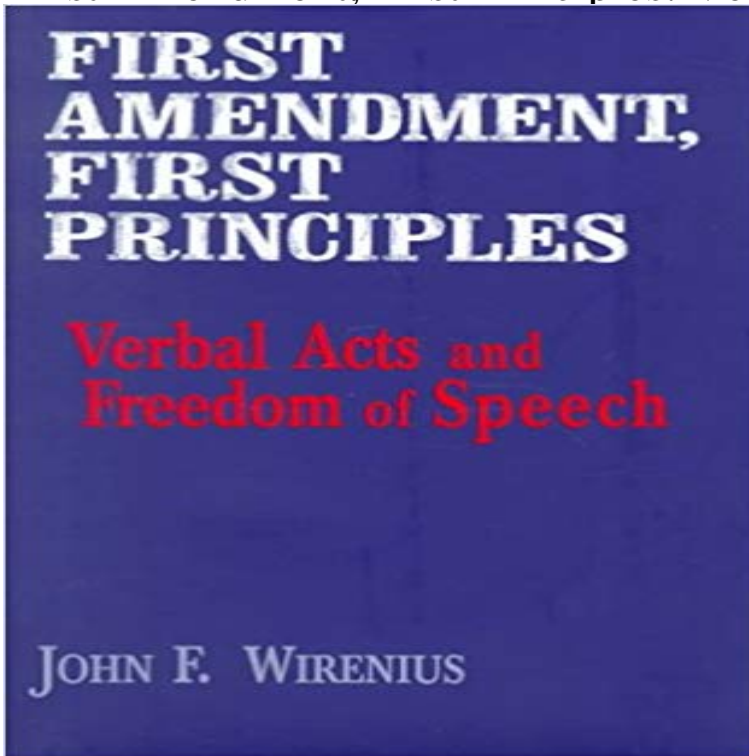


First Amendment, First Principles: Verbal Acts and Freedom of Speech



When the First Amendment, which embodies free speech, was written, it was primarily used as a tool to secure ratification of the Constitution. Today, more than 200 years later, it has come to symbolize the freedom of the United States. As we enter the 21st century, it seems that freedom of expression is becoming infinitely far-reaching. The explosion of the electronic media has made it possible for people around the country to communicate without government inspection or controls. The flip side of these boundless opportunities for individual expression is that they come with the threat of new censorship. On an almost daily basis, conflicts between our most cherished values and freedom of speech arise. Degrees of value are imposed upon speech as more and more cases are being decided based on a judge's subjective opinion of what is good and what is bad. In *FIRST AMENDMENT, FIRST PRINCIPLES*, attorney John Wirenius explores these and other challenges to freedom of speech. In his bold rethinking of the concept of freedom of speech, he examines the evolution of the current understanding (and misunderstanding) of the meaning of the First Amendment. What Wirenius writes is at once a thorough, scholarly examination of the body of law surrounding free speech and a passionate defense of how he feels the First Amendment should be treated. Wirenius reminds us that we must protect the First Amendment in order for it to protect us.
