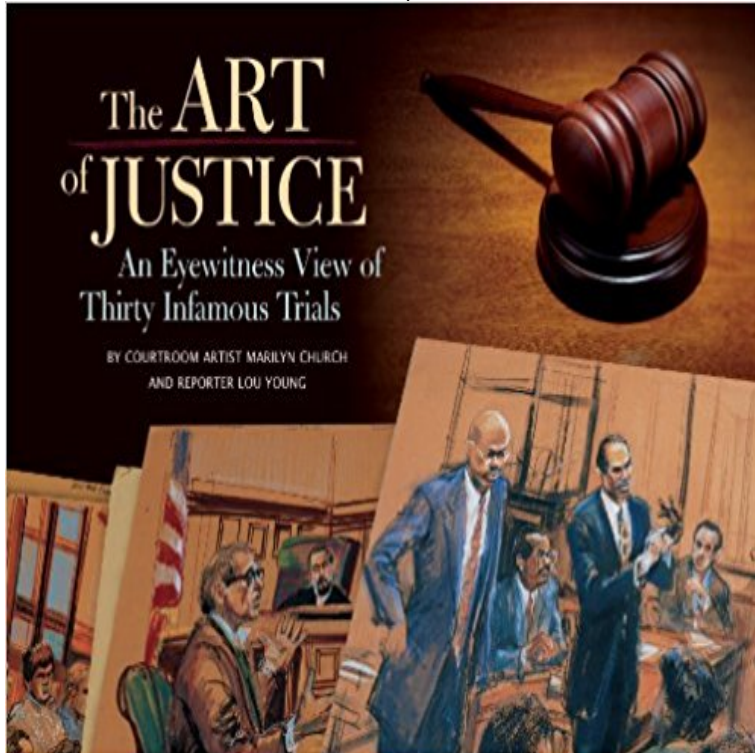


## Art of Justice: An Eyewitness View of Thirty Infamous Trials
