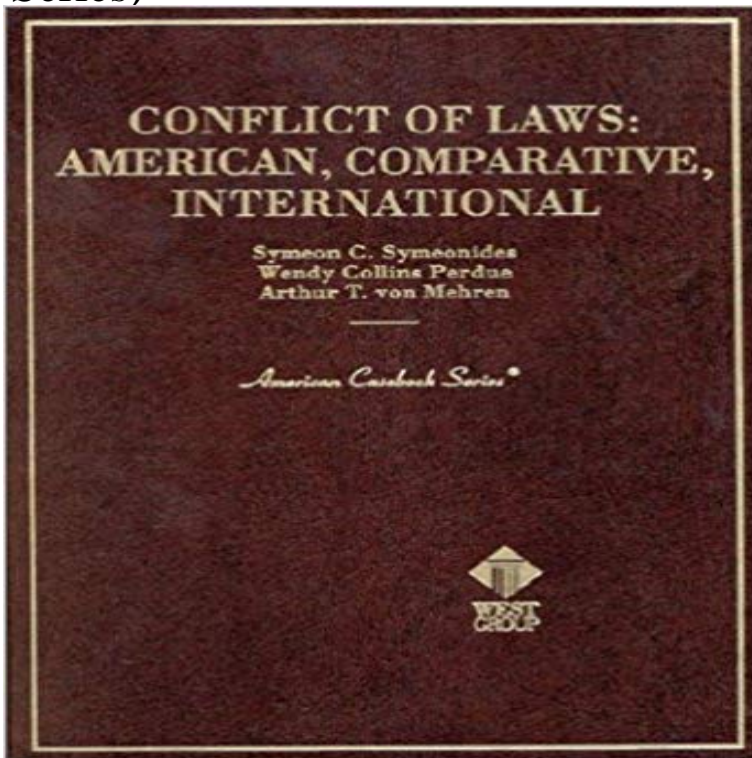


Symeonides, Perdue and Von Mehrens Conflict of Laws: American, Comparative, International--Cases and Materials (American Casebook Series)
