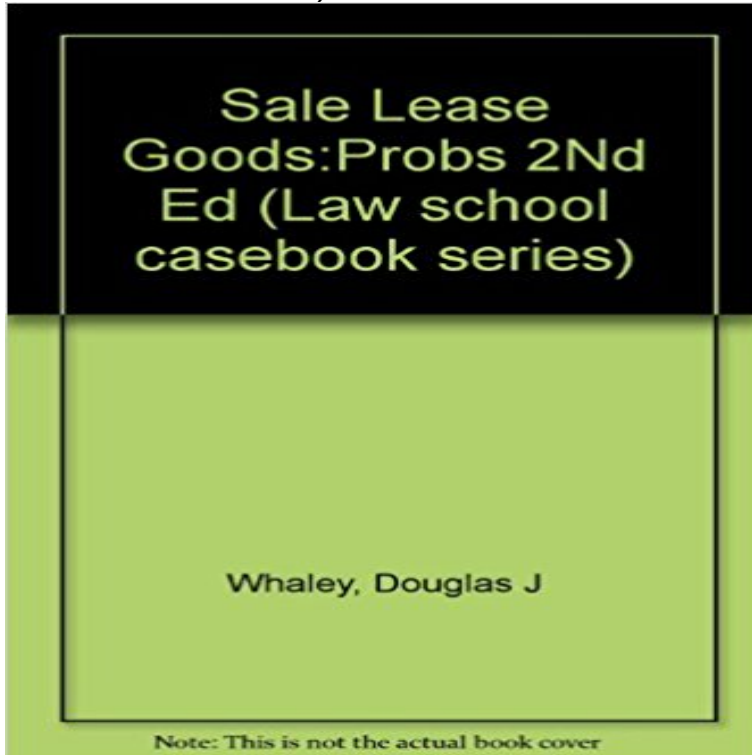


## Problems and Materials on the Sale and Lease of Goods (Law school casebook series)
