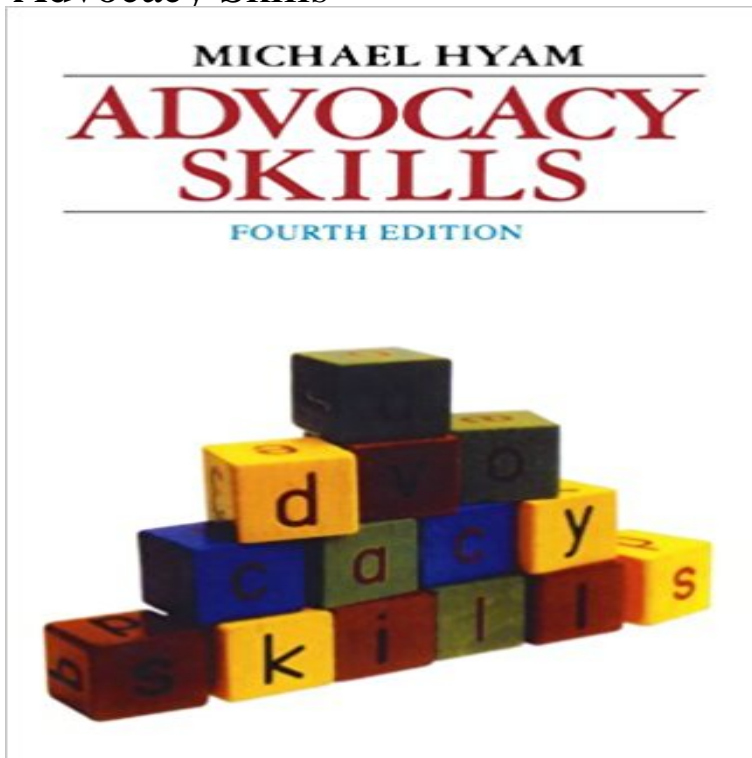


Advocacy Skills
