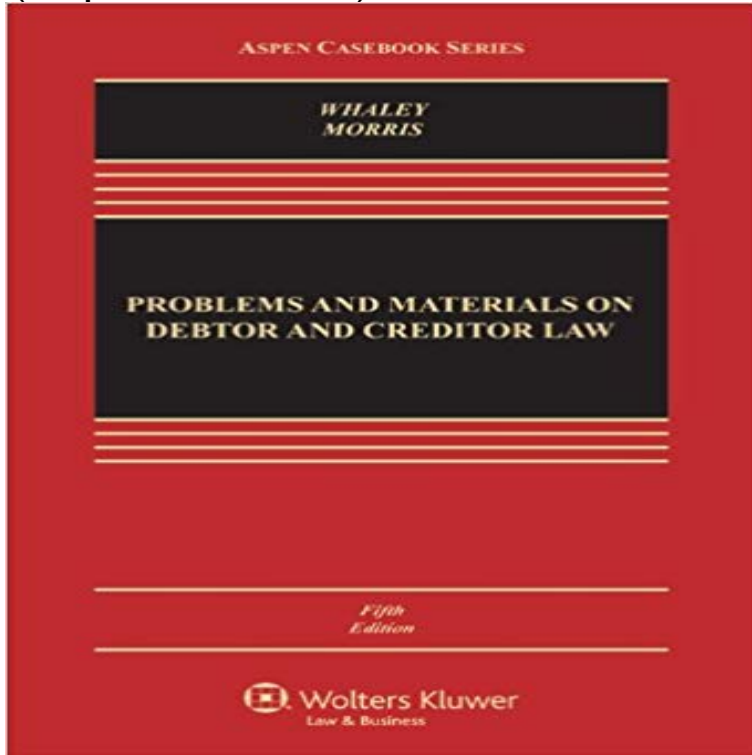

New Supreme Court cases have been added as well as some important lower court decisions--for example, the circuit courts--agreement that financing of negative equity on a traded-in vehicle as part of the purchase of a new car qualifies as a purchase money security interest. A new segment on the treatment of hostage value collateral in consumer loans explores various possibilities under both the Bankruptcy Code and Article 9 of the Uniform Commercial Code, and looks at the difference between the transformation rule and the dual status rule.
