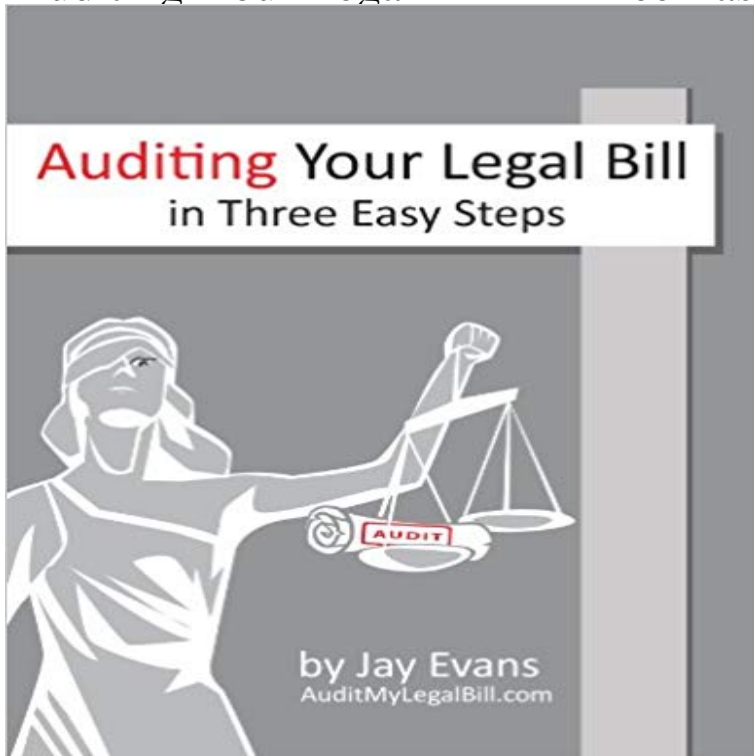


Auditing Your Legal Bill in Three Easy Steps
