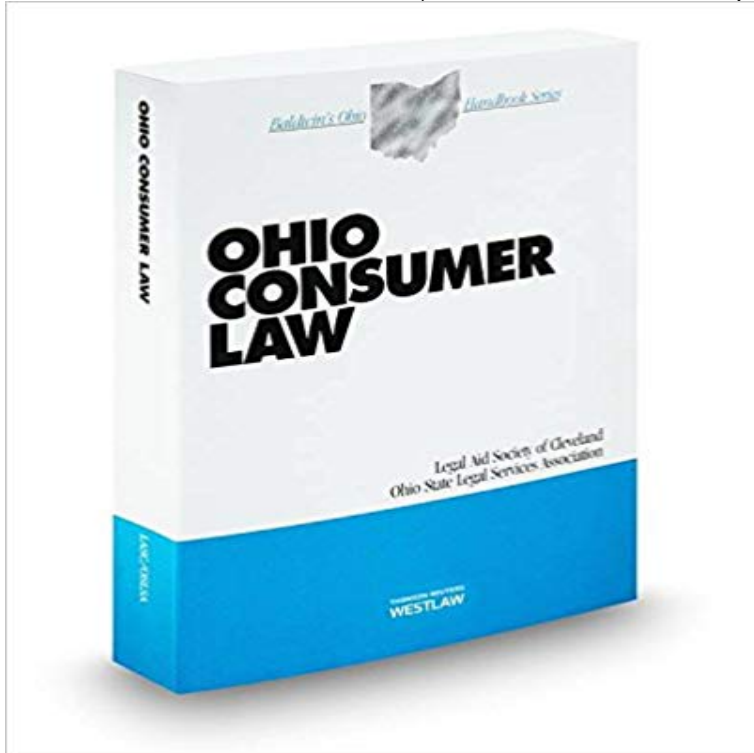


## Ohio Consumer Law, 2014-2015 ed. (Baldwins Ohio Handbook Series)
