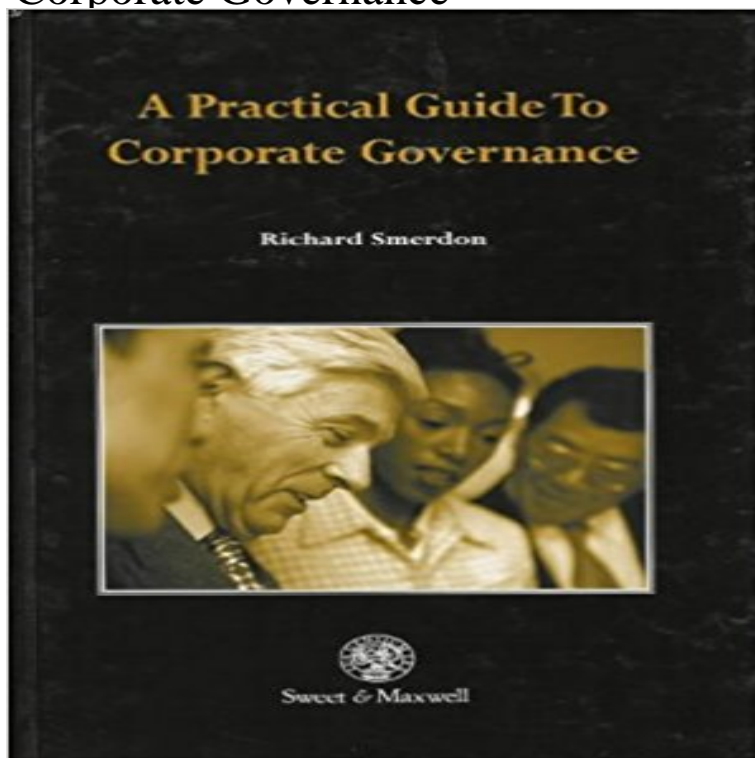


Corporate Governance
