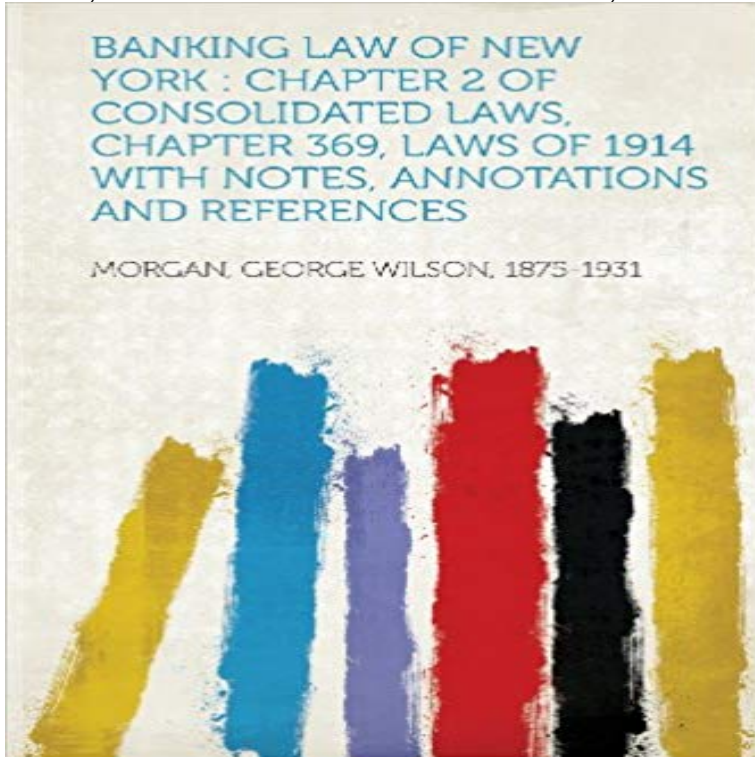


# Banking Law of New York: Chapter 2 of Consolidated Laws, Chapter 369, Laws of 1914 With Notes, Annotations and References
