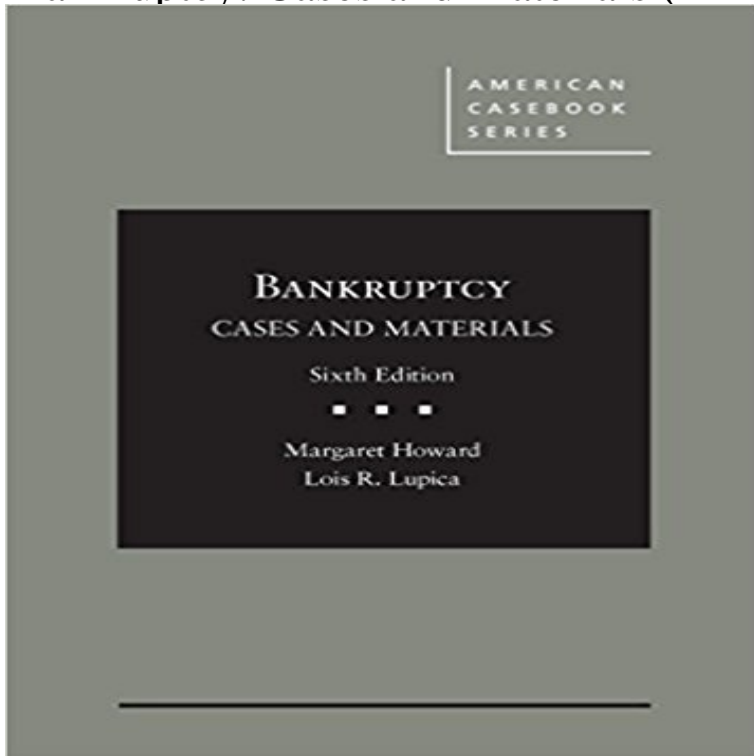


Bankruptcy: Cases and Materials (American Casebook Series)
