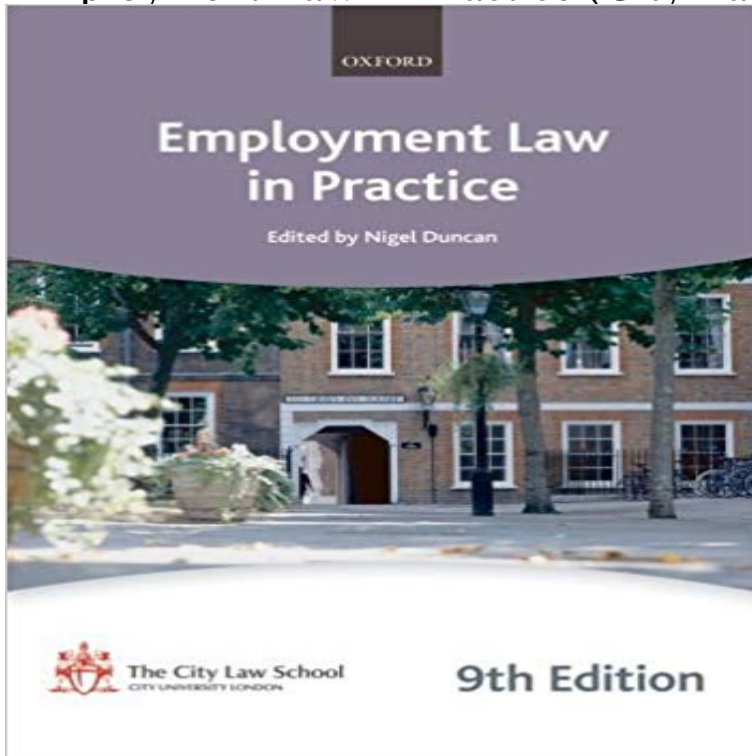


## Employment Law in Practice (City Law School Manuals 09-10)
