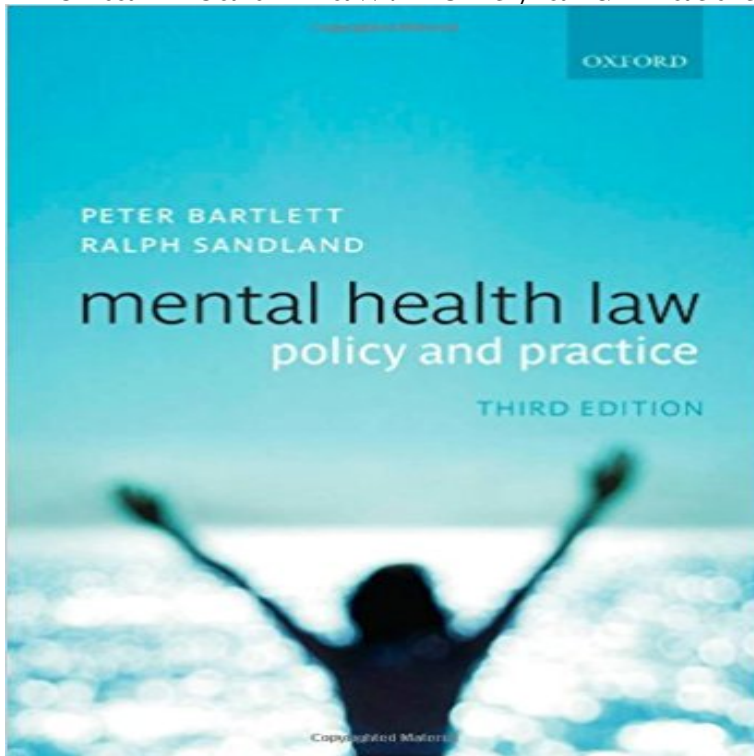


# Mental Health Law: Policy and Practice
