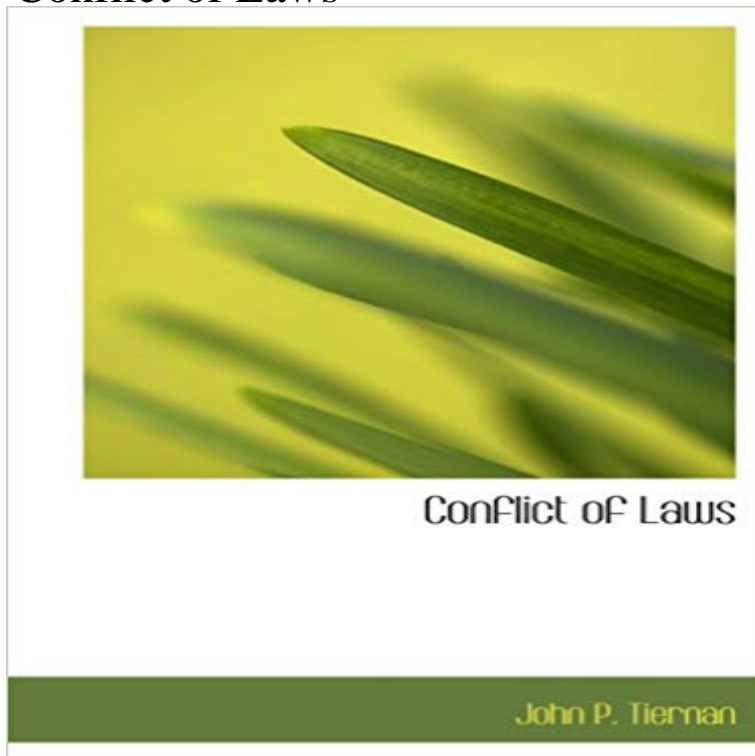


## Conflict of Laws
