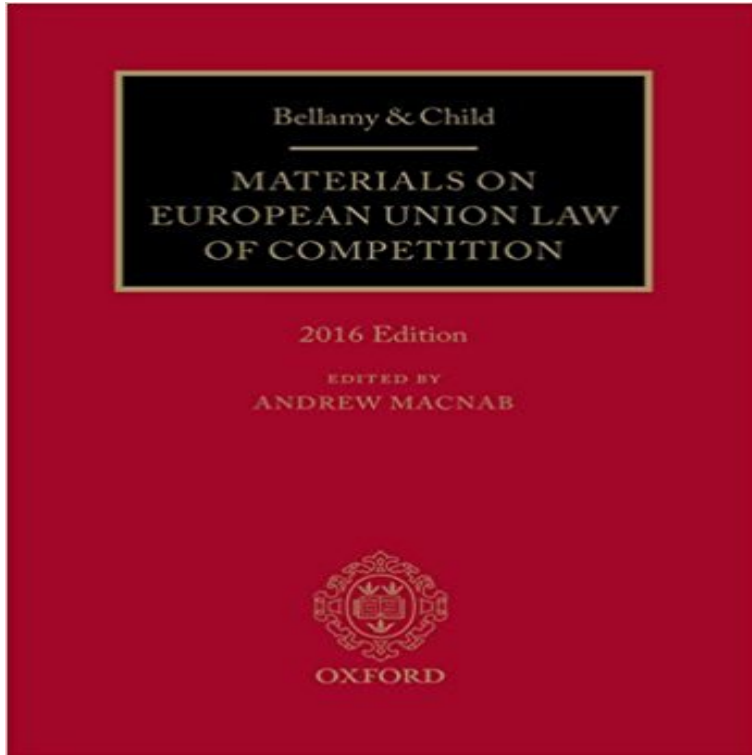


Bellamy & Child: Materials on European Union Law of Competition 2016
