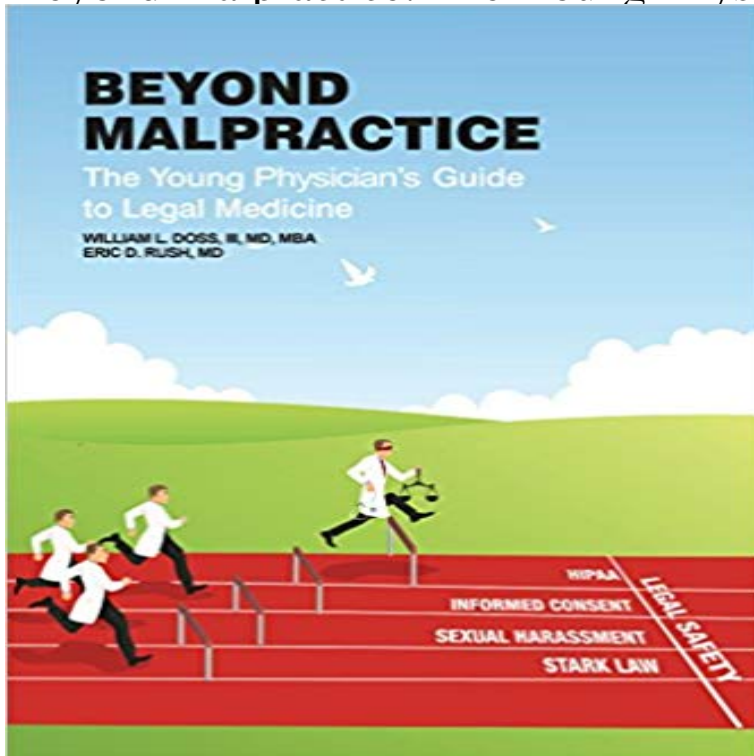


Beyond Malpractice: The Young Physicians Guide to Legal Medicine
