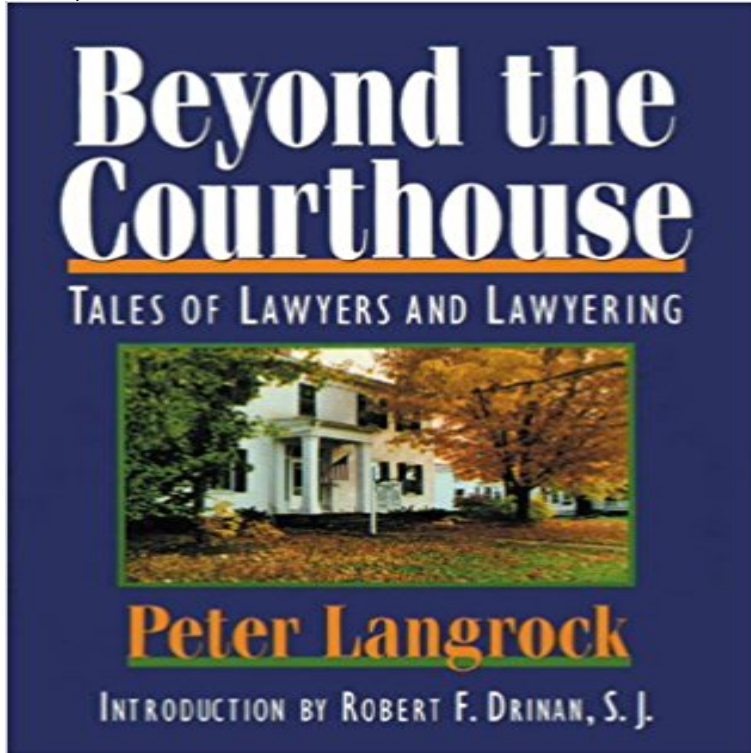


Beyond the Courthouse: Tales of Lawyers and Lawyering
